### Feminism Hijacked

In recent decades, feminism has been hijacked by single-minded pro-abortionists. Something they hide is that **early feminist leaders** were against abortion. Past abusive "traditional" patriarchal values sought power over women through control and domination. That tradition condoned violence on the grounds of personal privacy and used **baby killing as a solution** to problems.

In contrast, like the early American suffragists, today's pro-life feminists envision a better world in which no woman would be driven by desperation to abortion. These views represent a renaissance of the original American feminism. Our feminist foremothers didn't oppose abortion because it was less safe at the time. While they were certainly concerned for women's health, their terminology for abortion included phrases like "child murder," "infanticide," and "ante-natal murder," indicating a concern for the other individual involved as well.

● **Victoria Woodhull** (1875): "Men must no longer insult all womanhood by saying that freedom means the degradation of women. Every woman knows that if she were free, she would never bear an unwished-for child, nor think of murdering one before its birth."

● **Susan B. Anthony** ©. 1870s): "Sweeter even than to have had the joy of caring for children of my own has it been to me to bring about a better state of things for mothers generally, so their unborn little ones could not be willed away from them."

**Reclaiming & Restoring Family Culture**

Doing research in high school, Cristina Barba discovered that 87% of abortions were performed on unmarried women. "We don't have an abortion issue as much as a sex issue. If people were living according to the **Church's teachings on sexuality**, we wouldn't be dealing with abortion." In various ways, she has devoted her life to educating others about these teachings. Then, in 2014, she and 30 friends formed The Culture Project.

Based in Philadelphia, it has hubs in L.A. and Toledo, with a travel team based in San Francisco. The Culture Project invites **recent college grads** to live one year in community and minister to youth via talks on human sexuality, life and love. Barba strongly advocates that every family have meals together; share life together. Each family should be one "that loves one another, that forgives each other because we're going to screw up. 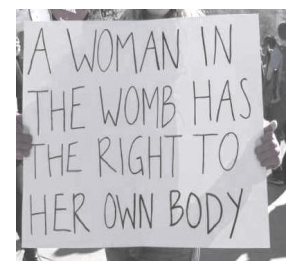
Actor Stephen Baldwin is slated to join the cast of an upcoming film detailing the true story behind *Roe v. Wade*. Baldwin, known for his role in "Usual Suspects" and many other films, joins Academy Award-winning actor **Jon Voight** and actor/producer **Nick Loeb** in the project. **Alveda King**, the niece of Dr. Martin Luther King Jr., and other pro-life leaders also are involved as co-producers.

Baldwin has been vocal about his conservative beliefs, sometimes causing tension with his equally famous brothers, Alec & Billy Baldwin. His role in the film is a strong sign of his support of **unborn babies' right to life**. The film will follow key advocates in the abortion fight in the 1970s, including former abortionist Dr. Bernard Nathanson and Betty Friedan on the pro-abortion side and Dr. Mildred Jefferson, the first African American woman to graduate from Harvard Medical School, on the pro-life side.

"Bernard and Betty, along with the team at Planned Parenthood, search the country to find a pregnant girl they can use to sue the government for her right to have an abortion," states the film's description. They find the "perfect pawn" in **Norma McCorvey**, the **Jane Roe** of *Roe v. Wade*, the U.S. Supreme Court decision that allowed abortion on demand in 1973. McCorvey later became pro-life and fought to overturn the infamous ruling that bears her name. She and others attested to her being used by abortion activists to achieve their deadly agenda.

The film will examine the **lies & manipulative tactics** of abortion activists, people like McCorvey and Nathanson who later had a change of heart, & dedicated pro-life advocates like Jefferson who fought valiantly to defend the right to life for babies in the womb. It also will address the racism intertwined in the abortion industry through Planned Parenthood founder **Margaret Sanger** and others, and Jefferson's fight for unborn babies as well as people of color.
