#### THE FIRST COVENANT

Under the first covenant of God with Moses and the Israelite people, the law was a gift, a great joy promising salvation to those who followed it. Part of this was the offering of perfect and unblemished animals for blood sacrifice to atone for the sins of the people. Those who kept the law were saved from their sins and from eternal death. The symbol of this covenant was circumcision, the assent of male Jews to the unbreakable law of God.

#### THE NEW COVENANT

Jesus was born under the law and kept the law perfectly in his life and teachings. Circumcised as a manifestation of his keeping of the First Covenant, Jesus was the perfect Lamb, the unblemished sacrifice to be accomplished in his life and death.

Jesus kept the law perfectly, and thus was the perfect Lamb whose death completed and fulfilled the law and the prophets. His resurrection ushered in the New Covenant, in which all are freed from the law and subject to the new law of love, not sacrifice.

What has this to do with the Christmas season? The birth of the Savior can never be separated from his life and death on the cross, incongruous as it may seem. Early English carols such as the "Coventry Carol" always connected Christ's birth and his death and kept the context in place.

Under the law, it was sons who by their circumcision and obedience were heirs of God's promises to the people. Under the new law of love in Christ, all people, men and women, boys and girls, are made adopted "sons of God" (see Galatians 4:7) and therefore full heirs of the promise of the reign of God. Under this New Covenant, we rejoice in our freedom as children and heirs of God's promise of redemption. In anticipation of this, the shepherds rejoiced at the fulfillment of the angels' word to them, and Mary saw the fulfillment of the angel's words to her. She kept all this in her heart, the pure and devoted heart of a daughter of God, Mother of God's only Son, and our Mother as adopted brothers and sisters of Christ.

Today's Readings: Numbers 6:22-27; Psalm 67:2-3, 5, 6, 8; Galatians 4:4-7; Luke 2:16-21
