- The **\$500.00 tuition deposit** is applied towards your tuition and divided over 10 months. The first tuition payment is due in August, 2019.
- Payments are over 10 months, beginning in August and ending in May.
- Credit card payment option
- Ability to go online and view your account and or make a payment.

This is the only acceptable method of payment. Payments will not be accepted at the school.

Collection of Tuition and Fees – School and Diocesan Policies:

- **New Families:** a **\$500.00 tuition deposit is due** with the Enrollment form. It will be applied towards your tuition and divided over 10 months. The first tuition payment is due in August, 2019.
- **Current families:** a **\$100.00 tuition deposit** is due with the **Enrollment** form. The **\$400.00 balance is due by June 1, 2019**. After June 1, a \$40.00 late fee will be applied. This will complete your child’s Registration and **guarantee** Enrollment for the 2019-2020 school year.
- **All outstanding tuition and/or fees** from the 2019-2020 academic year must be paid by **May 31, 2020** before a student will be readmitted in September.
- If you are late or have missed a payment you will receive an email and phone call from Smart Tuition. **SMART CHARGES A \$40 LATE FEE IF YOUR PAYMENT HAS NOT POSTED TO THEIR ACCOUNT BY YOUR DUE DATE.**
