Seek City approval on modification of Strategic Partnership Agreement to have it <u>automatically</u> renewed each ten years unless the City or District notify that they want the agreement to end. The current agreement states that the District exists for ten year terms, but does not limit the number of ten year terms. (see attached Proposed Amendment)
 - c. Consider setting the tax rates based on the needs of the District rather than considering the possibility of a rollback as a determining reason for a proposed tax rate.
 - d. As personnel in the Pool department change due to retirement or attrition, consider combining the positions and have a recreation manager rather than a coach.
 - e. Greg is working on taking over management of the maintenance department before Ruben retires.
 - f. Continually evaluate fees for all our facilities and increase or decrease as needed. Use comparable facilities as comparisons.
 - g. Perform a wage and salary survey to make sure we can attract quality people. We are currently participating in one being conducted by Brushy Creek MUD.
 - h. Expand the role of Pool Clerks to include food sales at both pools and possible sell other items as well. A) Pool clerk position; B) Food Sales at pools.
 - i. Look for ways to maximize use of the Community Center. (see attached AMCC Use calendar)
 - j. Look to create a long-term budget (20 year) with some of the above items that reduce costs or increase revenues so that long term plans can be made.
