As you are aware, any person who may have any possible contact with children must comply with PA State and Archdiocesan Safe Environment requirements. These are: completing PA State Criminal history, PA Child Abuse history and FBI fingerprint every **5 years**. Attend a training session called “Protecting God’s Children - Awareness Sessions for Adults, (which includes the Technology Addendum Training), and signing/returning the “Standards of Ministerial Behavior and Boundaries” acknowledgment form, the Mandated Reporter Training and the Mandated Reporter Acknowledgement form.

Volunteers who have been a PA resident for less than 10 years must obtain FBI clearance every **5 years** and if a PA resident for more than 10 years (**consecutively**) must sign an FBI Disclosure form every **5 years**. Our parish is now reviewing our files to ensure complete compliance. According to our records, the documentation checked below is missing from your file or an update is needed. **Please return the information to the Parish Business Office.**
