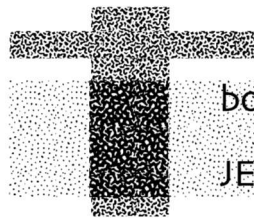

From Father Mike

By now I hope you have had a chance to start looking over the background info and design for the Uniting in Heart 2030 Pastoral Plan. You can see this by going to www.dol-in.org/uniting-in-heart or looking over the latest edition of The Catholic Moment. Not only is it important to begin to be familiar with the plan, but the bishop is presenting this as a draft for which he is inviting your feedback via email (unitinginheart@dol-in.org), voicemail (765-269-4669), or online (www.dol-in/uih-feedback). The deadline for giving feedback is July 19. While many people will go straight to the design of the plan, I believe it is important to look at the assessment of our current reality and to understand the vision of Uniting in Heart, especially the three pillars of mission, community, and witness. The design draft of the plan, which includes putting us into a regional pastorate with the parishes in Pulaski County, will only make sense in the context of the extensive data analysis and a focus on our core mission as Catholics. The research that assessed our current reality means that we are going to formulate a way ahead using facts and making decisions based on actual data instead of guesses or opinions of the condition of our parishes. The three pillars give us a clearer idea of what we are going to try to be as Catholics, which recognizes that God is calling us to be something more than we currently are as his followers and for others. It is a call to be missionary disciples of Jesus who foster a vibrant parish life and unapologetic witness to our faith. I'm excited that this Pastoral Plan will be inviting all of us to change in order to grow in our own faith and share it with others.

VICTIM ASSISTANCE MINISTRY-REPORTING AN INCIDENT

Who Should Make Reports:

- Victims of child sexual abuse by a person ministering on behalf of the Church
- Persons with a suspicion that a child may be sexually abused by a person ministering on behalf of the Church
- Persons concerned about violations about our Code of Conduct regarding appropriate behavior with children by any person ministering on behalf of the Church

How to Make a Report:

Indiana law requires any person who has reason to believe that a child is a victim of abuse or neglect must report immediately to:

- The local Child Protection Services agency (Hotline: 800-800-5556); or
- A local law enforcement agency. Under Indiana law, it is a criminal act not to make such a report. This law applies to all adults without exception.
