ZUBIK, TRUSTEE, his successors, and any other person, firm, or corporation acting by, through, or on behalf of said Parish, Diocese or Bishop-Trustee, the Indemnitees, for, from, and against all personal injury claims, property damage claims, bills, losses, costs, expenses, fees, awards, verdicts, judgments, damages, charges, or other consideration, due to the sole liability or sole negligence of the Indemnitees, due to the joint liability or joint negligence of the Indemnitees and Indemnitor, or due to the sole liability or sole negligence of Indemnitor, arising out of or due to any accident, incident, or occurrence due to the use of St. Irenaeus, St. Januarius, St. John the Baptist, St. Joseph, and Our Lady of Joy PARISH CHARITABLE TRUSTS property, causing personal injury, or injury leading to death, to any person or persons or property damage, including but not limited to servants, agents, or employees, guests and invitees of Indemnitees and Indemnitors, and said Indemnitors shall indemnify the Indemnitees from any claims, costs, fees, awards, verdicts, or judgments, arising out of any failure of the Indemnitor to comply with and perform all requirements and provisions agreed to and required by any law or ordinance governing the contemplated activities of Indemnitor.
