6. June is Torture Awareness Month

Solitary confinement is still an important issue, especially for juvenile offenders, despite reform at the federal level. "President Obama's actions at the federal level are important but largely symbolic for most of the 100,000 individuals currently being held in isolation. ## 7. Immigration - What can we do?

Rapid Response Training to Support Immigrants: "A group of organizations in Santa Clara County is setting up a Rapid Response Network (aka Migra Watch) that will mobilize when ICE raids occur in our community. Concerned community members can get training to be observers during raids. The network is setting up a 24/7 county hotline that immigrants can call when ICE is knocking on the door. The trained dispatcher will stay on the line, guiding the immigrant on his/her rights as the raid progresses. The dispatcher will also activate a system that automatically texts every trained observer who lives (or works) within a five-mile radius. The hope is that each zip code will have dozens of trained observers, so that five or so observers will be able to show up quickly at any given time.
