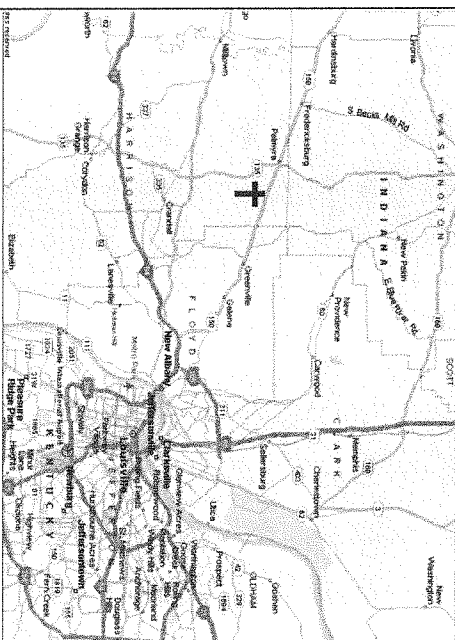

 - Top three finishers, 60+ years of age
