Christ the King's Extended Day program provides several attendance options to choose from. Please carefully consider your circumstances, and then select the option that best suits your needs.

Drop-In Hourly Features:

- Maximum attendance is \leq **1 day per week**, per child.
- Logged attendance is billed in arrears, and paid through the FACTS tuition management system.
- Any portion of an hour in attendance is rounded up to the next whole hour.
- Noon Dismissal Days = \$45 Flat Drop in fee (for any amount of time attended).
- Full Day School Closure Days = \$65 Flat Fee

Contract Rate Features:

- Full Day Flat School Closure Fee \$50
- Noon Dismissal Days included in Contract
- Contract amounts are **prepaid** and paid through the FACTS tuition management system.
- Any additional fees incurred in a calendar month are posted to the next month's payment due.
- Pro-rata refunds or credits are **not** made for days (or portions) not attended, for any reason.
- Unbroken Contracts throughout the school year that have paid for December will not be billed for June.

Policies applicable to all:

- **Late pick-up fee = \$15.00 plus \$1.00 per minute, each minute after 6:00 PM.**
- No make up for missed days or holidays.
- Extended Day payments will be made through FACTS tuition management system and are due on the 15th of every month.
- A two-week written notification is required to terminate a Contract Rate Financial Agreement. Fees continue to accrue until that two-week date.
- It is intended that your selection of **Contract Type** is binding for the entire school year. A change to the selected Contract Type is permitted solely at the discretion of the Director on a case-by-case basis, and only if certain requirements are met (see Director).
