**Respect Life:** In 1973, the Supreme Court's Doe vs. Bolton decision was the companion case to Roe vs. Wade, making abortion legal throughout pregnancy. Sandra Cano, the "Mary Doe" plaintiff of Doe vs. Bolton, technically won the case and the right to have an abortion – except that she never wanted one. Sandra was always a pro-life Christian even until her death in 2014. On March 23, 1997, she declared these memorable words: "I am Sandra Cano. I became known as Mary Doe when the U.S. Supreme Court released Doe v. Bolton, which allowed abortion for virtually any reason. I am against abortion; I never sought an abortion; I have never had an abortion. The Doe v. Bolton case is based on deceit and fraud."
