**Parishioners in good standing at other parishes in the Diocese of Lexington may receive the GSCS parishioner rate plus a \$500 per family stipend. A letter confirming your status from your home parish signed by your Pastor is required.**

**The parishioner tuition rate reflects tuition subsidized for active Catholic parent(s) by our parish's Offertory income. The non-parishioner tuition rate more closely reflects the cost of tuition per student. A parishioner's rate may be offered to you as a Baptized, registered Catholic household who is actively involved in our Parish Liturgical Life by your witnessed stewardship of the (1) universal "Precepts of the Catholic Church," (2) your noted presence in fulfilling your weekly Sunday and Holy Day Mass obligations, (3) your participation in service and life within our parish and (4) your contributions to the parish through the gifts of your action, abilities and your able financial offertory tithes at Mass. Accountability of these expectations of parish participation may be reviewed by the Pastor and School's Principal through our parish's confidential data base and one's ministry of presence within our parish.**

Payment options for tuition and school fees are:

- a) Pay in full by July 15. Please make all checks payable to Good Shepherd School or pay via automatic withdrawal through Facts Tuition Management Company. Other payment options are to enroll in a 10 month (August thru May), a 12 month (July thru June), or semi-annual (August and January) payment plan via automatic withdrawal through FACTS. An annual Facts enrollment fee of \$43 (\$10 for semi-annual plan, \$0 for full payment up front) will be charged to your account. Monthly withdrawals may be set up on the 5<sup>th</sup>, 15<sup>th</sup>, 20<sup>th</sup>, or last business day of the month. You are also given the option of making a down payment in the amount of your choice which would decrease the amount of your monthly automatic withdrawal.
- b) Pay by credit card via Facts. An additional credit card fee of 2.85% applies for each transaction.

When registration forms are received in the Business Office, you will subsequently receive a Tuition Contract. Following receipt of the completed contract in the Business Office, your Facts account will be finalized and automatic payments will begin on the dates you indicate on the contract. If you are new to Facts, instructions on setting up your account will be sent to you upon receipt of the contract.

Further tuition assistance may be available for K-8 families upon application and approval.
